Western Albemarle High School track repaved, Football field replaced with cooling material, parking lot expanded

High School Center II being constructed in Charlottesville next to Albemarle High School will open in 2026 serving 400 students. Geothermal environmental system installed that will handle 100% of the energy needs following success at Crozet Elementary using similar system that was able to be installed through a tax credit via the Inflation Reduction Act. HSC II will be for specialized learning in STEM, business, entrepreneurship, culinary, and woodshop. Will include a Community Resource Center to connect businesses with students.

Long term student population at Henley Middle will be relieved through opening new schools and potential redistricting but not additional construction to add capacity.
